OFFICIAL RULES

1. ELIGIBILITY

Contest is run by BMW Canada Inc. ("Sponsor"). Contest is open only to individuals who are participating in the BMW Drive It Home Experience offered at select golf clubs in Canada ("Event") and are legal residents of Canada, are at least twenty-five (25) years of age and hold a valid full class driver's licence as of the date of entry.

You are not eligible if you are: (a) an employee, officer, director, agent or other representative of Sponsor, its divisions, affiliates, subsidiaries, parent or related companies, advertising or promotional agencies, the prize suppliers, or (b) a member of the immediate family (defined as parents, siblings, children and spouse, wherever they reside), or household of any of the above persons.

2. HOW TO PARTICIPATE

NO PURCHASE NECESSARY. Contest begins on May 23, 2025 8:00 AM EST and ends on October 31, 2025 10:00 PM EST (the "Contest Period"). Participants in the "Drive It Home" Experience may enter the contest after submitting a booking and acceptance of these Official Rules.

All entries must be received by October 31, 2025, 10:00 PM EST (the "Contest Closing Date"). The clock used by the Sponsor in connection with the receipt of the entries will be the official clock to determine the date and time the entry was received.

Limit: Six (6) entries per person during the Contest Period. The odds of winning depend on the total number of eligible entries received. All entries become the property of Sponsor.

By participating in this Contest, entrants agree:

- (a) that the Sponsor and/or its authorized agents will collect, use, and disclose the personal information you provide for the purpose of administering this Contest and fulfilling prizes. With the entrant's consent, Sponsor will also initiate, maintain and develop a relationship with the entrant (including product and service information, offers, etc.). 3. PRIZE

There is one (1) Prize ("Prize") available to be won during the Contest Period.

Sponsor will not replace any lost or stolen prizes. Sponsor makes no representations or warranties with respect to any prize. Prize will be delivered via courier to the winner.

4. HOW TO WIN

A random draw will be conducted at 1 Pardee Avenue, Toronto, Ontario on November 3, 2025, at 1:00 PM ET from among the total entries received. The selected entrant (the "Selected Entrant") will be notified by email or telephone on or about November 5, 2025. Please check your e-mail and spam filters. If the Selected Entrant declines the Prize, incorrectly answers the mathematical skill-testing question, or otherwise does not respond or cannot be contacted within two (2) business days, the Prize will be forfeited and another entrant will be selected at random, with selections continuing until an eligible and qualifying entrant has been selected. The Prize will be drawn and awarded to the first declared winner.

In order to be declared a winner, the Selected Entrant must correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill-testing question to be administered by e-mail. If a Selected Entrant cannot be contacted and the skill-testing question administered within two (2) business days of the first attempt to contact, the Prize will be forfeited and may be awarded to an alternate entrant. The procedure outlined in paragraph 4 above will be repeated until the Prize has been awarded. There will be only one opportunity to answer the skill-testing question. 5. RIGHT TO VOID / TERMINATE / SUSPEND / MODIFY

Sponsor reserves the right, to terminate, suspend or modify this Contest, in whole or in part, at any time and without notice or obligation if, in Sponsor's sole opinion, any factor interferes with its proper conduct as contemplated by these Official Rules. Without limiting the generality of the foregoing, if Contest, or any part thereof, is not capable of running as planned for any reason, including but not limited to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, programming errors, or technical failures, which, in the sole opinion of the Sponsor, corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, Sponsor may, in its sole discretion void any suspect entries and: (a) terminate Contest, or any portion thereof; (b) modify or suspend Contest, or any portion thereof, to address the impairment and then resume Contest, or relevant portion, in a manner that best conforms to the spirit of these Official Rules; and/or (c) award the Prize from among the eligible, non-suspect entries received up to the time of the impairment in accordance with the winner selection criteria discussed above.

6. GENERAL CONDITIONS

Winning the Prize is contingent on fulfilling all the requirements set forth herein. All entries become the property of Sponsor, and none will be returned or acknowledged. Mass entries, automated entries, entries submitted by third parties, and any entries or prize claims that are late, incomplete, fraudulent, illegible, unidentified or delayed will be void. All entries and prize claims are subject to verification. Proof of entry submission does not constitute proof of receipt. Entrants agree to abide by these Official Rules. Decisions of Sponsor will be final and binding on all matters pertaining to this Contest. Contest is subject to all applicable federal, provincial and municipal laws. Void where prohibited. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, then the Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. Should a winner make any false statement(s) in any document referenced above, the winner will be required to promptly return to Sponsor the Prize, or the cash value thereof. Contest is subject to all applicable laws.

8. MISCELLANEOUS

Entrants who have not complied with these Official Rules are subject to disqualification. All decisions of Sponsor are final and binding in all matters relating to this Contest. Releasees will not be responsible for illegible, incomplete, lost, misdirected or late entries, which will be void. Sponsor may terminate or amend this Contest at any time without prior notice, if any factor interferes with its conduct as contemplated by these Official Rules. Contest is subject to all applicable laws.

In the event of a dispute regarding who submitted an online entry, the entry will be deemed submitted by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized account holder" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A selected entrant may be required to provide Sponsor with proof that he/she is the authorized account holder of the e-mail address associated with the selected entry.

Sponsor reserves the right at its sole discretion to disqualify, from this Contest and any future Contest or other

promotion conducted by Sponsors, any individual that it finds or believes to be tampering with the entry process or the operation of the Contest or to be acting in violation of the Official Rules or in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. 9. RESIDENTS OF QUEBEC ONLY

Any litigation respecting the conduct or organization of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux for a decision. Any litigation respecting the awarding of a prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement.
